FILLER DISSOLVING: EMERGENCY AND ELECTIVE MANAGEMENT

Educational Objectives

- Explain the pharmacology, mechanism of action, and proper indications for the use of hyaluronidase in dissolving hyaluronic acid dermal fillers.
- Explain how to conduct thorough patient evaluations to determine when dissolving HA fillers is necessary, including identifying complications like overcorrection, migration, or vascular occlusion.
- Review correct dilution, dosage, and injection techniques for administering hyaluronidase to dissolve dermal fillers safely and effectively.
- Recognize complications related to dermal fillers, such as uneven results or vascular compromise, and understand how to prevent adverse outcomes.
- Discuss individualized treatment plans for patients requiring HA filler dissolution, balancing safety with aesthetic goals.
- Identify signs, symptoms, and risk factors for complications including vascular occlusion.
